

Wolf Theiss advises Sekyra Group on sale of a new office project in Prague to Banka Creditas

Prague, 19 August 2024 – Wolf Theiss Czech Republic's Real Estate team advised Sekyra Group, a major Czech developer, in relation to the sale of a real estate project to Banka Creditas. The project, a new office building, will become the new corporate headquarters of the buyer, a prominent Czech bank.

The building is expected to be completed within three years and it will provide a leasable area of over 17,000 sq. m. to Banka Creditas and other companies from its group. The building will be a part of a new quarter, Rohan City in Karlín, vibrant and rapidly developing neighborhood in Prague. The project was designed with strong emphasis on using environmentally friendly technologies to ensure sustainable operation of the entire building.
